


from the Preamble to the Point No Point Treaty Council Constitution

...the Port Gamble S'Klallam and the Jamestown S'Klallam Tribes, of the Point No Point Treaty Area, recognize the responsibility and need to protect and advance the treaty reserved hunting, fishing and gathering rights of [their] Tribes.

[The Port Gamble S'Klallam and the Jamestown S'Klallam Tribes] further recognize that [their] inherent traditional and cultural rights constitute vital and irreplaceable resources for [their] future. These resources are essential for the social, cultural and economic self-sufficiency and well-being of [their] Tribal communities.

[The Port Gamble S'Klallam and Jamestown S'Klallam Tribes] believe that in unity and mutual respect [they] can best accomplish [their] community goals, not only for the benefit of Indian people, but for all people.




#### LAND ACKNOWLEDGEMENT STATEMENT

"Every part of this soil is sacred in the estimation of my people. Every hillside, every valley, every plain and grove, has been hallowed by some sad or happy event in days long vanished."

Chief Seattle 1854

We would like to begin by acknowledging that the land on which we gather is within the aboriginal territory of the sudwabs "People of Clear Salt Water" (Suquamish People). Expert fisherman, canoe builders and basket weavers, the sudwabs live in harmony with the lands and waterways along Washington's Central Salish Sea as they have for thousands of years. Here, the sudwabs live and protect the land and waters of their ancestors for future generations as promised by the Point Elliot Treaty of 1855.

#### Access to Healthcare themes

- Lack of culturally competent services (20)
- Difficulty navigating the system (10)
- Negative healthcare outcomes due to lack of trust (14)
- Determinants of health play a key role in health outcomes – even when there is access to healthcare (16)
- Current systems are inadequate to meet community needs (15)



# Substance Use Disorder/Opioid themes

- Substance Use Disorder broad topic (27)
  - Impact on community (individuals, youth, family, society) (5)
  - Data showing impact by population group (4)
  - Prevention what's being done (4)
  - Inter-relationship of substances (gateway) (3)
  - Accessibility (2)
- Opioid specific topic (9)
  - Many of the above and crisis due to deaths
