- Meeting for a little over a year and so far, we have talked about:
 - Three barriers to health
 - Housing and homelessness, mental health, access to healthcare
 - o Deep dives: Housing, mental health
 - Vision and mission statements, norms
 - Feedback to KPHD, VMFH about strategic plan, community health needs assessment, respectively
 - Relationship building
 - Sharing who we are, what we are doing, what we care about
- HEC Member Interviews from Maria (presented by Siri)
 - o Preliminary findings done in Feb. 2024
 - o 61 participants were invited, 39 interviews were completed, two participants declined, 66% participation rate (from Feb. 15 to March 1)

- Interview questions shared questions about substance use disorder/opioids, lack of healthcare access
 - Results
 - "Which topics should be discussed first?" 20 responses for access to healthcare, 16 responses for substance use disorder/opioids, 1 unable to finish survey (37 total)
 - Access to healthcare themes
 - o Lack of culturally competent services (20)
 - o Determinants of health play a key role in public health outcomes, even when there is access to healthcare (16)
 - Current systems are inadequate to meet community needs
 (15)
 - o Negative healthcare outcomes due to lack of trust (14)
 - o Difficulty navigating the system (10)
 - Substance use disorder (SUD)/opioid themes
 - o Goal was to understand what specifically people were interested in general SUD or opioid-specific?
 - 27 were interested in broad topic area, 9 wanted opioid-specific
 - Meetings 33 of 37 people said they could stay if the meetings were extended to two hours from the current 1.5 hours
- Future meeting topics
 - Want our meetings, agenda to be informed by participants
 - o Proposal for the rest of 2024:
 - March hear about feedback from interviews
 - May Healthcare with a focus on options based on interview inputs/local resources
 - July Substance use disorders/opioids
 - September Recap and updates on the top 3 barriers, discussion around actions
 - November Action planning

 - Feedback from the group on future meetings
 - Back to conversation on topics/action
- Proposed idea for next meeting: Focus on future group actions? Figure out where folks want to get involved
 - o For example: Legislative, planning opportunities, etc.
- Diversity Equity and Inclusion program manager at county intro for Kimberlee Williams (kywilliams@kitsap.gov)
 - Her role at the county and what it looks like in her office and out in the community
 - Some of the things she enjoys most is what she gets to partner with us on
 - County brought her in to focus internally and externally, a lot of work but really is two sides of the same coin proactive and reactive
 - Supportive in times of crisis George Floyd was murdered, tribal member was murdered, many different incidents, etc. Racist acts mentioned.

- Showing up to be a voice of support or be a listening ear
- Internally Create training for staff, especially those out in the community
 - Create opportunities for elected officials all the way down to hourly employees to learn, watch them grow and create culture of inclusivity and belonging here in Kitsap
 - Not something that has always been, not something people feel even today
- Externally Building bridges between county and community partners, residents to make sure they know of services available to them through county and bringing down barriers to the services
 - Ex: A blind woman who needed assistance at today's job fair when her assistance didn't show up
 - Has worked hard to do this since November, there shouldn't be a barrier we can't overcome so residents can access services they have a right to
